- * Jr. Devo Team athletes must be able to ski Chair 5 & 11 terrain without difficulty to participate in KSEF
- * Jr. Devo Team athlete parents must be available for lift ride assistance if child under the age of 7, or unable to meet Vail Resort lift riding requirements. All athletes must be able to ride chairs without full time coach's assistance.
- * Jr. Devo Team athletes are not permitted to participate in Friday or early load training sessions.
- * Jr. Devo Team, U12 and U10 athletes will NOT be permitted or assigned lockers in the KSEF Team Room.
- * Helmets are required for KSEF participation.

Before any participation and training with KSEF Programs or Staff is allowed:

- Full tuition, and volunteer deposit must be paid at the start of program or prior to participation in any training/racing with KSEF.
- Waivers/Liability Release form, Medical Release forms, Code of Conduct and Team Rules and Etiquette must be read, signed, and returned with registration form and tuition payment.
- Please make the check payable to **KSEF** and mail to, **Jim Reilly, 365 Ranchitos del Sol, Aptos, CA 95003**. DO NOT mail to Kirkwood P.O. Box.
- Any approved tuition installment payments **MUST** be one month ahead of any participation and will be assessed a \$75.00 processing fee per month till paid in full. Any returned payment incurs a s \$75.00 per athlete fee and must be paid prior to any training or participation with KSEF.
- Age class race schedules will be based upon USSA Far West /Tahoe Race Series schedules. If KSEF Director determines a need to provide a race or coach assistance for any athletes traveling outside Tahoe/Mammoth area (examples but not limited to Regional, National,) race venues, all associated travel expenses will be allocated equally to all participating athletes of that venue. Payment for said travel costs will be due within ten (10) of receipt of invoice or will incur late fees and interest.

KSEF reserves the right to determine qualification and eligibility for participation in KSEF Programs.

KSEF Parent Volunteer Agreement Form

2023/2024 Season

KSEF relies heavily upon the support and dedication of parent volunteers to enable KSEF to continue to provide the best ski team program in Tahoe. To maintain reasonable tuition rates, avoid added payroll costs, and equitable sharing/distributing of the volunteer's workload in supporting our team, the KSEF Board of Directors will continue with the team's parent volunteer program.

This parent volunteer program, which is widely used by most youth sports clubs throughout the country has become a welcomed benefit to our KSEF program. At registration time, each family participating in KSEF (not each individual athlete) is required to fill out this form and return it with a separate check in the amount of \$ 400.00 (aside from the tuition payment). This \$ 400.00 payment will be applied towards the parent volunteer deposit requirement. (Checks to be made out to KSEF).

During the 2023/2024 KSEF program season any parent of a family that contributes a minimum of eight (8) hours of volunteer service, for specific tasks predetermined by KSEF Director, during the 2023/2024 KSEF season, will be reimbursed, in full at the end of the season for fulfilling the parent volunteer hour requirement.

If your family does not complete the full eight (8) hours of volunteer required hours, your family's deposit will be forfeit and no refund will be issued. Note no refunds will be issued, this year, for partial hours served.

There are many volunteer opportunities available. These specific tasks will be communicated throughout the season, as the specific needs arise, via the Program Director's weekly updates. Examples of volunteer opportunities are as follows: Assisting staff with set up and removal of B-Nets; cleaning of the team room and associated hallway; setting hill sideline closures; installing safety ribbons; MLK raffle assistance; uniform/hoodies distribution; Banked Slalom race; Torchlight Parade and Head 2 Head event organizers. These are just a few areas where we need your help. It is also up to the parents to ensure your families volunteer's hours have been logged towards required volunteer hours. The Directors maintains the official log, and at any time you can check with the Director to ensure your hours have been logged correctly. We recommend you verify your hours, within a week, after completing a task.

On behalf of the KSEF Board of Directors, Program Director, and entire coaching staff we thank you for your cooperation and look forward to working together to make 2023/2024 season the best year for KSEF.

GENERAL CODE OF CONDUCT

The following code of conduct represents a code of behavior for all athletes participating in the Kirkwood Ski Education Foundation. The code reflects a commitment to academic achievement at school and athletic achievement on the mountain. We require that each athlete and a parent sign a copy of this code which then becomes an agreement between the program, the athlete and parents.

1. Athletes in the program shall maintain high standards of moral and ethical behavior, which includes self control, responsible behavior, consideration for other's physical and emotional well being, courtesy, good manners and sportsmanship at all times. No athlete is above any other athlete. Any "bullying" will result in immediate dismissal from the team room, race events and/or participation in the KSEF program.
2. Athletes in the program shall abstain from the use of illegal drugs and the consumption of alcohol and all forms of tobacco. Athletes of the program shall maintain a healthy lifestyle. Athletes of the program shall maintain honesty and truthfulness in all they endeavor.
3. No athletes of the program shall commit a criminal act. This includes while participating in or representing KSEF at home or away at competition, and is grounds for immediate dismissal.
4. KSEF athletes shall refrain from use of profane language and disruptive behavior at all times while participating or representing KSEF. KSEF athletes are representatives of the KSEF Program and the town of Kirkwood, Kirkwood Ski Resort, and the surrounding School Districts, and shall act accordingly. Athletes of the program shall be respectful of all the ski area facilities, boundaries and employees at Kirkwood while visiting other areas.
5. Athletes of the program shall be respectful and follow directions of all race officials and volunteers. Athletes shall abide by the FIS and USSA rules of competition in all events as a KSEF member. All athletes/guardians are responsible for properly submitting race entries on time for scheduled races. Athletes and parents shall read the Far West and KSEF Newsletters to stay informed.
6. All KSEF athletes and parents shall assist in fundraising.
7. Athletes and parents shall assist and support any member/staff of KSEF and show leadership to younger members.
8. If you are not able to attend a training session, call and let the coaching staff know within 24 hours.
9. Athletes are encouraged to maintain a minimum 3.0 grade point average.

TEAM RULES AND ETIQUETTE
Locker Room/Sun Meadow 3 & 4 Basement:

1. KSEF U14 and older members only in the KSEF Team locker room. Parents must stay out during the morning rush. U12/10 and Jr. Devos will not be assigned lockers..
2. KSEF offices and coaches' room are off-limits to all athletes and for business use only. This is a zero-exception rule regardless of family relationships.
3. Your equipment and clothing are your responsibility, not KSEF's. Your personal belongings must be locked in your locker at the end of the day or when you are not present in locker room. All equipment must be removed at end of season. Anything belongings left in the team room is not the responsibility of KSEF and may be disposed of with KSEF having no liability for replacement or value of any disposed items.
4. Use a combination lock only, athletes must provide administrative staff with the combination.
5. No defacing the outside or inside of any locker. Lockers will be assigned prior to start of season on a first come first serve basis.
6. No skis or gates may be placed against the walls, left in hallway or stairwell. Gates go in the gate storage area.
7. Adhere to all tuning bench rules. An adult **MUST** be present if anyone under 18 yrs. old is using tuning bench or wax irons.
8. The locker room and KSEF hallway are not a playground, behave yourself.
9. **ONLY** the coaching staff may operate the electronic equipment.
10. In the hallway, skis are to be carried in your hands straight up and down, **NOT** on your shoulders.
11. Enter & exit through the outside upstairs door only. Do not kick the door to open it.
12. Only one athlete may use the bathroom at a time.
13. We are guests of Sun Meadows, all other buildings, hallways, stairwells, or elevators are off limits.
14. The hallway/elevators/basement area/parking garage are not places to play. KSEF does not allow any playing in these areas. Remember there are homeowners who live in Sun Meadows who want a pleasant and safe living environment. Respect the property and owners, and be courteous to others while in the building.
15. The hallway is not a storage place for clothing/equipment, it is not a dressing area, or a place to eat lunch or snacks.
16. KSEF property within team room/hallway is not to be removed from the area or used for a purpose which it is not designed for unless instructed by a KSEF staff member.
17. If and when you are asked to do something by a coach, do so immediately without confrontation.
18. Please show respect towards your fellow athletes' rights and their equipment.
19. Athletes will not borrow without permission, hide, or vandalize any teammate's property or equipment that is kept in the KSEF Locker Room or in an athlete's locker.
20. Assist/support any fellow member both in the team room and on the hill. Treat team mates with respect.
21. Safety Bars/Comfort Bars **MUST** be used by KSEF athletes at **ALL** times. Athletes not using Safety Bars may be excluded from that day's training. **NO EXCEPTIONS!**
22. Any eating of food must be approved by KSEF coaches. Anyone found not cleaning up will have KSEF lunch room privileges revoked.
23. Always be courteous in the lift lines and **NEVER** cut ahead of anyone who has been waiting ahead of you. Do **NOT** use the Ski School line unless you are a registered Jr. Devo member or Jr. Devo coach. If you are caught using the Ski School line you will be dismissed from training for the day.

Discipline for Rule Violations

Any violation of General Code of Conduct and Team Rules and Etiquette will result in disciplinary action up to and including suspension of team room usage and/or training privileges.

Please remember, you represent the Kirkwood Ski Education Foundation and your actions/attitude speaks volumes about our program. No one athlete or parent is above the program itself.
